Student Internship Program Description:

Urban League of Broward County's Student Internship Program (SIP) is a 12-week immersive unpaid internship program placing undergraduate and graduate students in placements working alongside program and administrative staff throughout the organization.

Interns will have the opportunity to work on a variety of projects that advance their department's work to better serve disenfranchised communities. In addition, interns will have several professional development opportunities throughout the semester. These include Senior Management Brown Bag Discussions and networking with the Young Professionals Network.

Essential Functions and Job Responsibilities

This position will work with clients in assistance towards home ownership and with foreclosure prevention. The intern will gain experience in the intake process, documentation requirements, housing education workshops, and HUD-approved counseling.

- Provide administrative support to Housing department staff.
- Provide current information to program clients.
- Assist in preparation for workshops and events.
- Prepare client files by copying required documentation and organizing paperwork.
- Track program related calls on a log.
- Prepare mailings for programs in the department.
- Assist in the monthly report preparation and submission
- Provide support, as needed, to other programs including cross-training in other program areas.
- Other duties as determined by the Supervisor.

Work Environment

This job operates in a professional office environment, off-site venues and outside areas in various weather conditions. This role routinely uses standard office equipment such as computer, phones, photocopiers, filing cabinets, and fax machines.

Physical Demands

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is regularly required to stand; use hands to finger, handle, or feel; reach with hands and arms and talk or hear. The employee is occasionally required to sit; climb or balance; stoop; kneel, crouch, or crawl; and walk.

The employee must occasionally lift and/or move up to 15 pounds.

Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception and ability to adjust focus.

Position Type and Expected Hours of Work

This is a part-time intern position (15-25 hours per week). Days and hours of work may vary; however, the company's business hours are Monday through Friday from 8:00 a.m. to 5:00 p.m.

Urban League of Broward County seeks passionate, intelligent, and critical-thinking students with an interest in not-for-profit management and program delivery to join us. Qualifications include:

- Exceptional undergraduate and graduate students are invited to apply and must have a current minimum GPA of 3.0.
- Major/Coursework in social work, human services, or public administration preferred. Knowledge of financial literacy is helpful.
- In addition to academic success, the Urban League seeks individuals who are committed to making a difference in their community, exemplify leadership in both traditional and non-traditional ways, and are willing to work hard.
