Summer Internship Program Description:

Urban League of Broward County's Summer Internship Program (SIP) is a 10-week immersive unpaid internship program placing undergraduate and graduate students in placements working alongside program and administrative staff throughout the organization.

Interns will have the opportunity to work on a variety of projects that advance their department's work to better serve disenfranchised communities. In addition, interns will have several professional development opportunities throughout the summer. These include Senior Management Brown Bag Discussions and networking with the Young Professionals Network.

Essential Functions and Job Responsibilities:

As the **Media Design Intern** in the Philanthropy & Communications Department, the individual will play a key role in visually communicating the mission, events, and impact of the Urban League of Broward County—particularly during our historic **50th Anniversary year**. This position is ideal for a design-savvy individual who is passionate about branding, nonprofit storytelling, and creating visuals that resonate with diverse audiences.

Interns will collaborate closely with the communications team to develop digital video content that commemorates our **50**th **Anniversary celebration**, and other donor and community engagement efforts.

- Produce well-edited, captioned video stories highlighting 50 years of service
- Conduct interviews with clients, staff, and community members
- Use Adobe Illustrator, Photoshop, and Canva to develop high-quality, on-brand visual content.
- Sort, digitize, and tag photo and video archives
- Publish YouTube videos weekly (plus Shorts)
- Deliver a searchable media archive Produce sustained channel development for YouTube.
- Organize and maintain digital folders and version control of graphic files.
- Ensure accessibility and inclusivity in design practices.
- Perform other creative tasks and administrative duties as assigned.

Work Environment

This job is operated in a professional office environment, offsite venues and outside areas in various weather conditions. This role routinely uses standard office equipment such as computer, phones, photocopiers, filing cabinets, and fax machines.

Physical Demands

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is regularly required to stand; use hands to finger, handle, or feel; reach with hands and arms and talk or hear. Position Type and Expected Hours of Work

This is a part-time intern position (20-25 hours per week) from July 15 – September 13, 2025. Days and hours of work may vary; however, the company's business hours are Monday through Friday 8:00 a.m. to 5:00 p.m.

Urban League of Broward County seeks passionate, intelligent, and critical-thinking students with an interest in not-for-profit management and program delivery to join us. Qualifications include:

- Exceptional undergraduate and graduate students are invited to apply and must have a current minimum GPA of 3.0.
- Coursework in human resources, volunteer management, business, nonprofit management, marketing, hospitality, event planning, etc. preferred.
- In addition to academic success, the Urban League seeks individuals who are committed to making a difference in their community, exemplify leadership in both traditional and non-traditional ways, and are willing to work hard.
